

2026 – 2029 Call for Projects Program Guidance Packet

Berrien Cass, & Van Buren Counties

CMAQ Introduction

The Southwest Michigan Planning Commission (SWMPC), the regional planning organization for Berrien, Cass, and Van Buren Counties in southwest Michigan, is announcing the availability of funding for transportation projects through the Congestion Mitigation and Air Quality Improvement (CMAQ) program. This program is funded through the Federal Highway Administration (FHWA), with oversight by the Michigan Department of Transportation (MDOT). The CMAQ program funds projects that reduce transportation emissions, contributing to the attainment or maintenance of air quality standards under the Clean Air Act.

CMAQ funding is intended to help improve air quality in counties designated as non-attainment or maintenance for Ozone (formed by NOx and VOC emissions), CO, and PM 2.5. Currently, Berrien County is non-attainment for the 2018 ozone standard, while Cass and Van Buren counties are in maintenance under the 1997 standard. Applicants should be aware of the risk that FHWA could change its position on the eligibility of maintenance areas to use CMAQ funds. Applicants should also know that the funding amounts presented are estimates and may be modified if the Federal formula for State CMAQ apportionment changes.

Application Deadline

Applications are due to SWMPC by 5:00 p.m. on Monday, October 7, 2024

Eligible Applicants

Eligible applicants include cities, villages, county road agencies, regional planning agencies, and transit agencies. Townships wishing to apply must partner with their county road agency, listing the county road agency as the applicant on the application. The township may hire a consultant for the application and engineering, with the county road agency serving solely as a passthrough agency.

Eligible Projects

CMAQ funding must be used for projects that provide an air quality or congestion reduction benefit without increasing single occupancy vehicle capacity and do not simply maintain an existing facility.

Eligible Costs

Only construction and implementation costs are eligible for CMAQ funding. Preliminary and construction engineering is the project sponsor's responsibility to complete without CMAQ funding.

Local Match Requirements

A minimum match of 20 percent of the total participating construction cost is required for most CMAQ projects (See Eligible Projects for a list of projects that do not require a local match).

The project sponsor must have already committed matching funds when the project is submitted. Proposals which indicate that the sponsor will pay more than the minimum local match will be identified for the CMAQ Project Selection Committee and may be given extra consideration. The application includes a Certification of Matching Funds which must be signed, assuring that the sponsor will have the funds to cover the match and any cost overruns.

Project Selection Process

CMAQ projects will be selected for each county, by committees for Berrien, Cass, and Van Buren counties consisting of one representative from each agency that submitted at least one application. The selection will occur at an open public meeting. Before this meeting, all applications will be posted online at swmpc.org for public comment.

The committee will base its selection on the FHWA evaluation criteria that include emissions reduction, cost-effectiveness, and how the project contributes towards other state and regional planning goals. Illustrative List of Projects

Projects that meet the selection criteria but were not chosen by the committee for the 2026-2029 fiscally constrained list will be added to an illustrative list. If additional CMAQ funds become available before the next call for projects occurs, the committee will award the CMAQ funds to a project from the illustrative list.

General Considerations for Federal Funding

Projects carried out using CMAQ funds must comply with applicable provisions in Title 23 of the United States Code dealing with Federal-aid highways, such as project agreements, authorization to proceed before incurring costs, prevailing wage rates (DavisBacon), Buy America, competitive bidding, and other contracting requirements, regardless of whether the projects are located within the right-of-way of a Federal-aid highway.

Application Instructions

There are two separate fillable PDF applications attached to the email sent out with the 2026-2029 CMAQ Program Call for Projects, one for road agencies, and the other for transit. The two applications can also be found at the links below:

- Transit Agency Application

The applicant must fill out a separate application for each project. Although this is a call for 2026–2029, projects currently approved and programmed for 2026 do not need to reapply.

Part of the application requires an estimate of the project's emission reduction. <u>Applicants must use the</u> appropriate FHWA CMAQ toolkit to calculate the emission reduction.
