Call to Order and Roll Call

Technical Advisory Vice Chair, Joe Ray, called the meeting to order at 1:30 PM and Kim Gallagher took roll call.

Changes to the Agenda

Gallagher announced that the agenda items regarding the Niles Dial-A-Ride Transportation (NDART) safety targets and state of good repair targets are being removed since NDART Director Pepper Miller is on vacation. NATS has 180 days to vote on supporting the transit targets after NDART adopts them, allowing approval to occur at a future meeting.

Public Comment

Approval of the Minutes from the October NATS Meeting

Motion to approve the minutes from the October 22, 2024 Joint NATS Technical Advisory Committee and PolicyCommittee Meeting. Made by Sandra Seanor and seconded by Roseann Marchetti. **Motion approved.**

Staff Report

Gallagher announced that the Project Review Subcommittee, originally scheduled for this morning (November, 26th, 2024), will be rescheduled, due to required attendees not being available.

Gallagher provided an update on the Regional EV Survey, noting that 33 responses were received. The survey results will inform the development of the EV Readiness Plan, which will serve as a toolkit for local jurisdictions, covering costs and potential locations for EV infrastructure. The first technical memo is expected to be completed in February.

Local Project Updates

Joe Bellina presented an update on the 2024 Gumwood Realignment Project stating that construction is complete and the roundabout at Gumwood and Redfield is open to traffic.

Butch Payton gave an update on the Bertrand Road Project stating that construction is complete.

Joe Ray gave an update on the 2025 Sycamore Street project stating that the GI was submitted, and he is awaiting NEPA approval.

Brandon Kovnat reminded attendees that the FY 2025 Elhart Road project was being removed from the NATS TIP since it was already completed using local funds. He said that then presented the following Amendments:
